OLD BUSINESS

White Church Road/Park & Recreation Interest -

Supervisor Cressler stated that he doesn't think the Township and Park & Rec are ready for a long-term agreement since there is no master plan and only grass is being planted at this time.

The Township is not ready to turn the parcel over for a long term lease at this point, but a short-term agreement should be in place to establish who will mow the grass and liability.

MOTION: Supervisor Cressler authorized Mr. Sean Shultz, Esq, to

begin working out the terms of a short-term

intergovernmental agreement with SCPRA. This agreement is for the use of the White Church Road recreational parcel for soccer fields. Supervisor Witter seconded the motion which

passed unanimously.

REPORTS OF TOWNSHIP OFFICIALS AND AGENCIES

<u>Subdivision & Zoning Ordinances</u> - Solicitor Sean Shultz stated that he is finalizing the ordinances and they are on schedule for March $28^{\rm th}$ adoption.

<u>South Penn Enduro Race</u> – Supervisor Cressler received the letter.

<u>Senior Center Agreement</u> – Solicitor Shultz has been trying to get in touch with a representative from Messiah to discuss the agreement, but has not been able to talk with anyone directly. No action.

<u>US Xpress Tree Planting</u> – Supervisor Cressler stated that now that the US Xpress plan has been signed and recorded, he would like to take the next step and plant the trees.

Supervisor Witter added that since it is USX property, it will need to go through them to proceed, but the Township will pay the bill.

Solicitor Shultz will get in contact with a representative from US Xpress and let them know the Township is ready to plant. In essence, the Township would pay USX to plant the trees. Mr. Shultz will get an agreement in writing.
