Township Getting First Traffic Lights

Olde Scotland Road (State Route 696) is going to look a little different in 2008. The township is going to be home to four traffic lights. The lights are scheduled to be installed this summer. One light is going up on Olde Scotland Road at a new intersection at the entrance of the new warehouses near Criders' Meats. One is going up at the intersection with Mount Rock Road and the other two will be at the interstate ramps.

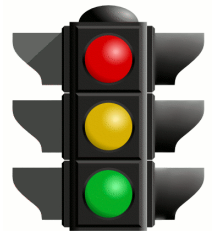
Liberty Trust, a developer of warehouses, is required by the department of transportation to install these lights due to an anticipated increase of traffic for the new warehouses proposed near Interstate 81.

The state requires townships to own these lights even when they are on a state route. Your supervisors negotiated with Liberty Trust to offset all costs associ-

ated with the new lights. Installation, maintenance and repair, and even insurance costs will be billed back to the developer forever.

We felt it is important that the general citizenry not be burdened with the costs of these lights. The lights are necessary as our community grows. We are happy to report that our zoning is working and all these trucks coming and going to these new warehouses will all stay within 2 miles of the interstate exit and travel on State Route 696.

You should see a lot of construction starting around the exit in the near future. Your supervisors will continue to direct growth to the proper parts of the township while attempting to preserve our communities character as much as possible.



SPRING BULKY TRASH DAY—APRIL 12TH

Southampton Township will hold its' semi-annual bulky trash day on Saturday, April 12th from 7:00am until 3:00pm. Township households can once again take advantage of this opportunity to get rid of any junk that they have collected over the year(s) that they cannot put into their regular trash. The drop off spot will be at the township building on Municipal Drive. Drive *behind* the township facility where someone will greet you. We will get your name and address and answer any questions you have about disposal of your junk. There are certain items that we cannot take and others that we have to charge a minimal fee.

Items that we cannot accept at junk day are:

- Liquid wastes of any kind including waste oil, paint, insecticides, inks, solvents,
- Aerosols or pressurized containers
- Motors containing gasoline or oil
- Tanks-welding or cooking
- Ammunition or anything explosive
- Dead animals
- No 55 gallon drums,
- Hospital/ biohazard waste, industrial wastes of any kind
- Anything containing asbestos
- No contaminated soil or yard waste
- Computer monitors cannot be accepted

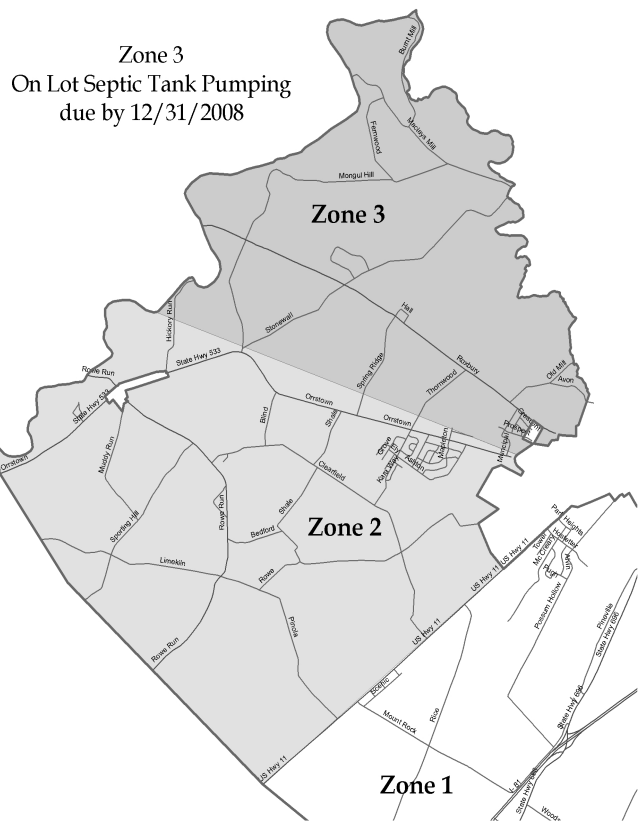
Septic System Pumping Reminder

YARD WASTE DISPOSAL

Residents of Southampton Township can take advantage of the Borough of Shippensburg's compost facility on Avon Drive. Stop by the Borough Office at 111 S. Fayette St. for a \$20 permit which is good for the entire year.

Compost Facility Hours of Operation

March,

Tues. & Thurs. 12:00-4:00 Sat. 9:00-3:00

April

The compost facility will be closed on all holidays and December 24th to January 1st.

BURNING ORDINANCE

Under normal circumstances residents may burn organic plant material such as tree limbs, brush, shrubbery etc., and household rubbish limited to products consisting entirely of paper and/or wood. **NO other materials such as tires, roof material, garbage, manure, automobiles, wire insulation, or any plastic items may be burned!**

Southampton Township Requirements

- Contained burning must be at least 25ft. from nearest building and property line.
- Open fires must be at least 100ft. from nearest building and 50ft. from nearest property line.
- All burning must have adult supervision who shall be present at all times and extinguish the fire completely when not attended.

If you are going to burn brush, it is always a good policy to notify the township in advance at 532-9041 as well as West End Fire and Rescue at 532-5555.

BULKY TRASH (Cont. from Pg 1)

Of course, the township must reserve the right to refuse anything that it thinks is a hazard.

The township will take up to 4 automobile tires from each household 15" or smaller free of charge. We do not accept tires with rims on. There will be a fee charged for any more than 4 tires or any tires larger than 15".

Refrigerators, air conditioners or anything that has Freon in will also have a \$5.00 charge.

The township can accept automobile batteries in small numbers.

We will have big roll-off containers on site. If you are able bodied, you will be directed to a self unload zone to help keep things moving. If you need help we will direct you to an area where we will be happy to help you.

As a free service to assist elderly, handicapped, and those who have no other means to transport bulky items, or just need special help, a group of volunteers, directed by township resident Lane Thrush and the gang from Point of Difference Team @ RE/ MAX Realty Agency will pick up the items for you. You will still be responsible for any fees that may be associated with the junk. If you need help just call Renee at 709-7063 by Monday, April 7th, to schedule their help. They will be picking up on Friday, April 11th.

Please keep our township clean of junk by getting rid of it properly.

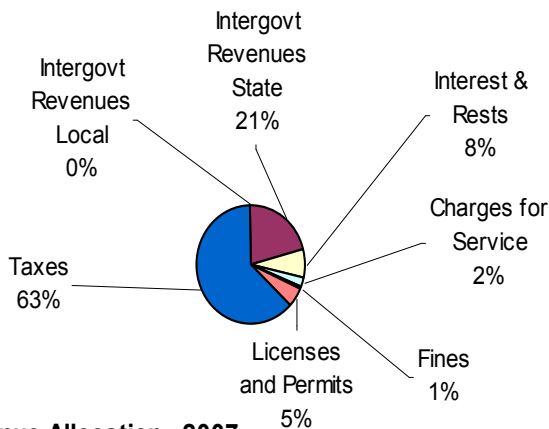

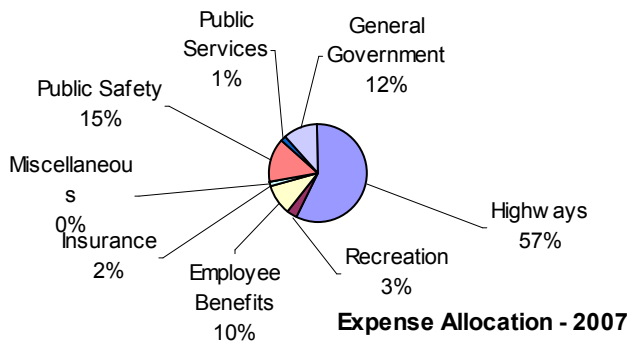
