## Township Has Positive Balance

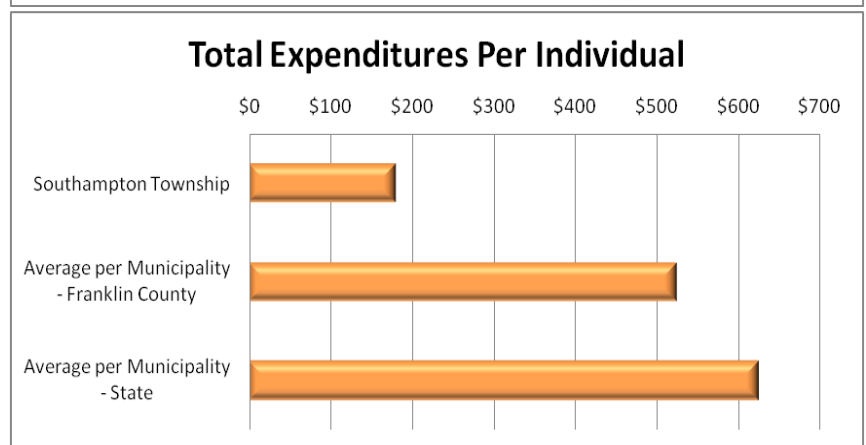
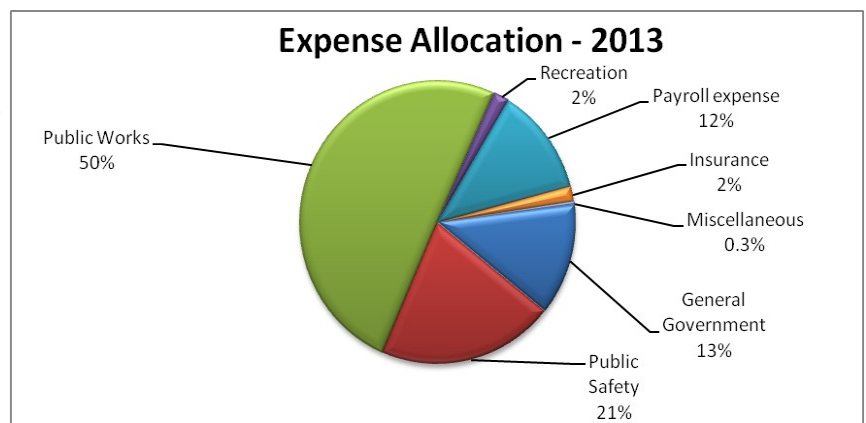
Your township supervisors are happy to report that we were able to keep spending in line with revenue again in 2013. Expenditures for the year were \$1,528,201, and we ended with a surplus of \$64,998. The township is keeping operations within budget without requiring property tax, except for a very small amount (.4 mills) which goes towards the library.

The pie chart entitled, Expense Allocation – 2013, contributed by our accountant, indicates the breakdown of township expenses. Our biggest expense is “Public Works,” which takes up half of our budget. Public Works includes road construction and repair, winter maintenance, leaf collection, trash days, clearing brush and weed control on our right of ways.

“Public Safety” is the second biggest township expense. We support our fire companies financially and help whenever we can. Please thank and support our volunteers from West End, Pleasant Hall and all the other emergency services for helping our community.

We continue to see growth in the township. Your supervisors are actively planning for those impacts while trying to maintain the rural nature of our community everywhere we can. The bar graph to the right demonstrates the cost per individual living in Southampton Township compared to other municipalities in Franklin County and the State.

There is always the threat from Harrisburg to force more mandates that stress your wallet. You should be aware of a current idea that has recently resurfaced, which is a mandatory police fee for State Police. A few in Harrisburg believe that because we don't have our own local police, we should be required to pay for the State Police twice. The State Police have reported to our township that we have no “discernible criminal trends.” Creating a local police force here would be like annually building a bridge with nothing to cross. This could be a million dollar mandate for our residents.

## Bulky Trash Days set for April 11th and 12th

Southampton Township will hold its semi-annual bulky trash days on Friday, April 11th, from 12:00pm until 5:00pm, and on Saturday, April 12th, from 7:00am until 12:00pm. Township households can once again take advantage of this opportunity to discard any junk they have collected over the year(s) they cannot put into their regular trash. The drop off spot will be at the township building on Municipal Drive. Drive *behind* the township facility where someone will greet you. We will log your name and address and answer any questions you have about disposal of your junk. There are certain items that we cannot take and others that we have to charge a minimal fee.

We cannot accept liquid wastes of any kind, including: waste oil, paint, insecticides, inks, solvents, aerosols or pressurized containers. No motors containing gasoline or oil, tanks-welding or cooking; ammunition or anything explosive. No 55-gallon drums, hospital/biohazard waste, industrial wastes of any kind, or anything containing asbestos. No contaminated soil, yard waste or dead animals. Of course, the township must reserve the right to refuse anything that it thinks is a hazard. No CRT TVs.

The township will take up to 4 automobile tires from each household 15" or smaller free of charge. There will be a \$2.00 fee for each additional tire. We do not accept tires on rims. Tires larger than 15" are \$10.00 each. We reserve the right to refuse tires based upon size.

Refrigerators, air conditioners, dehumidifiers, or anything that has Freon in will also have a \$5.00 charge.

The township can accept automobile batteries in small numbers.

We will have big roll-off containers on site. If you are able bodied, you will be directed to a self-unload zone. If you need help we will direct you to an area where we will be happy to assist you.

As a free service to assist elderly and handicapped, Lane Thrush of RE/MAX Realty Agency in Chambersburg is offering volunteers to pick up the items for you on Thursday, April 10th. You will still be responsible for any fees that may be associated with the junk.

\*Please Note: Bulky Trash Days are for residential purposes only.

It is now illegal to put the following in your trash: desktop computers, laptops, monitors, computer peripherals and televisions.

### Recycling E-Waste

Southampton Township will continue to collect desktop computers, laptops, monitors, computer peripherals, flat-screen TVs and other electronics at our semi-annual bulky trash day. They will be properly recycled at NO CHARGE to our residents.



Unfortunately, **we still cannot accept any Cathode Ray Tube (CRT) TVs.** They are the older "box" style televisions. There are no R2 certified recyclers who will take them at this time.

Please *gently* place your computers, peripherals and flat-screen televisions under the equipment sheds. If you need help, pull your car down to the loaders and we will be happy to assist you.
