Dustin Rickabaugh with Affordable asked how a 50% bond as delivered would work with the potential for a large percentage of them being FOB?

Supervisor Cressler replied that the performance bond would be based upon approximate quantities that you are awarded, all quantities more or less. Solicitor Shultz confirmed.

Doug Shields – Code Enforcement – Gave the following update:

Fire Fighter Advisory Committee - Report from the meeting that he attended.

<u>Rail Road Crossing</u> - Mr. Shields stated that the Rail Road Crossing work will begin this week. Work is currently being done on Mount Rock Road, then it will move to Possum Hollow and paving will be done on both roads on the same day.

<u>Shippensburg Water</u> – Mr. Shields has a meeting with the Borough and Rettew to camera the road establishing pre-existing road conditions. New hydrants will be put in. The road will not be closed.

MaClays Mill Bridge - Renovations will begin in Mid-May.

REPORTS FROM TOWNSHIP OFFICIALS

<u>Parks and Rec/White Church Road Parcel Agreement</u> – Solicitor Shultz brought up the short-term lease agreement for the White Church Road recreational parcel.

Supervisor Cressler suggested waiting until Sean can review all Park & Rec organizational documents before drafting the lease agreement. Secretary/Treasurer Cressler will get all of the documents to him.

Bid Opening
