Fernwood Road Speed Limit

MOTION: Supervisor Witter moved to conduct a traffic count on Fernwood Road and to send the results to Tim at Martin & Martin. Supervisor Cressler seconded the motion which passed unanimously.

Public Works Staffing

Samuel Cressler reported that he has three applications in his file of people that are interested in a Public Works position.

MOTION: Supervisor Cressler moved to contact the people listed on the three applications he has in his file. He will then see if they are still interested in a position and will set up interviews. Supervisor Witter seconded the motion which passed unanimously.

WEFR Request for Paving Assistance

Paul Witter reported that Shawn Corwell from Greene Township contacted a paving company to pave West End Fire & Rescue's parking lot. Greene Township is willing to give \$5,000 toward the project if Southampton Township will give \$5,000 and West End will cover the remaining balance.

MOTION: Supervisor Witter moved to give \$5,000 to West End Fire & Rescue Company to be put towards the parking lot paving project. Supervisor Cressler seconded the motion which passed unanimously.
