### **VISITOR REMARKS**

### Shippensburg Area EMS Report

William Klusman reported that Shippensburg Area EMS had substantial cutbacks in 2019 due to outside agency issues. He informally asked if the supervisors would consider helping to offset the cost of their substation which is \$12,000 annually.

Supervisor Cressler replied that they can discuss financial contributions; however, normal procedure is to formally request assistance in September and October to get into the following year's budget.

William will get more numbers together for further discussion.

#### Mrs. Tanya Williams

Mrs. Tonya Williams lives on a corner lot and therefore has two front-road setbacks. She stated that the Township ordinance creates a hardship for her because she cannot put up a sufficient fenced-in area for her three dogs. She is asking for some relief.

Randy Brenize stated that even though it is a reasonable request in this situation, the Township needs to be careful not to set precedence.

Supervisor Cressler stated that any modification should have more details such as traffic counts, vehicle speeds, sight triangle etc. The supervisors discussed the situation and instructed Mr. Doug Shields to get more data for the next meeting on February 11<sup>th</sup>.
