MaClays Mill Road Detour M.O.U.

Supervisor Cressler reported that PennDOT is getting ready to replace the MaClays Mill bridges, one in 2021, the second in 2022. He requested the detour route be Stonewall Road, but PennDOT insisted on using Mongul Hill Road. He also said the MaClays Mill Road and Bridges will be video taped prior to and after the construction work.

presented for the MaClays Mill Bridge repair as presented. Supervisor Cressler seconded the motion which passed

unanimously.

#### NPDES Permit for Furnace Run

Supervisor Cressler stated an NPDES Permit will eventually need to be required for Furnace Run Park. A large amount of fill is available. This would be a huge asset for the park. He would like to pursue the NPDES permit ASAP.
