# **OLD BUSINESS**

Furnace Run Pocket Park

Southampton Township has received a cost estimate from Barton & Loguidice for Phase 1 (Gateway Park) Final Design with a "hybrid approach" in the amount of \$47,500. This is a maximum amount based upon the Township's involvement.

# Matrix HOP - Township Applicant

Matrix needs to install drainage under Olde Scotland Road, SR696. PennDOT has changed their requirement for their HOP application and now requires the Township to be the applicant. The Supervisors would like to be co-applicant with Matrix.

Solicitor Kelso stated the Supervisors will have to sign the application, but Matrix can be responsible through an agreement by resolution.

MOTION: Supervisor Hall moved to sign the PennDOT HOP Application

subject to an agreement by resolution with Matrix.

# Spring Ridge Road Traffic Study

Completed traffic studies for Spring Ridge Road called for four 35 MPH speed limit signs to be installed and for two stop signs on Mayapple Road.

MOTION: Supervisor Hall moved to advertise for ordinances adopting

speed limit signs on Spring Ridge Road and for the Stop

Signs on Mayapple. Supervisor Cressler seconded the motion

which passed unanimously.

### SUBDIVISION AND LAND DEVELOPMENT

Bond Reduction Request - Matrix Shippensburg - Lot A

Maria reported that Matrix is requesting a reduction in their \$3,094,070.00 bond. Martin & Martin has been doing weekly inspections and has reviewed the Matrix as-built. They have recommended a bond reduction to \$129,614.00.

unanimously.

# Solicitor's Report

Solicitor Kelso still doesn't have any agreements and amendments between CFJMA and the Borough of Shippensburg. She is still working on it.

# Code Enforcement Officer

Cattle-Crossing Sign - Jamie White reported receiving a letter from Lamar Wadel requesting a "cattle crossing sign" or blinking light on White Church Road. They have had issues with traffic not stopping while they move their cattle across the road twice a month.

No formal action taken.

Pugh Drive – Jamie reported that the resident on Pugh Drive has not complied with the screening.

Matrix – Lot A – Jamie said Walmart has relocated the fire alarm IT panel in the middle of the building and that is not acceptable to the fire department. He will be contacting them.

Camper Living – In a response to Supervisor Brenize's inquiry, Jamie said the zoning ordinance says you can live in a camper for six months out of a year and another six months for the following year, but that is all.
