# SUBDIVISION AND LAND DEVELOPMENT

SD2023-005 Matrix 11 & 12 Land Development Plan

Tim Cormany reported the plan was tabled at the last Planning Commission meeting while the modifications were being acted upon. The Supervisors have since approved all four of the modification requests. The plan now incorporates the approved modifications.

Maria Misner said the Township is experiencing a lot of trash on United Drive. She asked if there was a note they could put on the plan that the Township could easily reference for getting the tenant to keep the trash off of the property.

Mr. Kurt Williams stated he would be ok with adding a note that the owner/applicant shall comply with the trash per the Township Nuisance Ordinance and trash would be a violation of the approved plan.

MOTION: Maria Misner moved to approve the final Land Development Plan for

Matrix 11 & 12 provided the comments from Tim Cormany's letter dated March  $20^{\rm th}$  are satisfied including Fire Chief written comments and note referencing trash is put on the plan. Daryl Zimmerman
