of Auditors that Supervisors receiving Vacation, Sick, Holidays, Comp Time, Overtime, Bereavement, Personal Days and Pension be set as outlined in the Employee Manual, and that Supervisors receive a base wage increase of 4% as set for the employees for the year 2024.
